Summer

Ms. Tyler-Schohl reminded the members that with summer comes seasonal employees. She noted that the May safety bulletin dealt with training your seasonal employees. She informed the members of a case in another JIF where a lifeguard on his *paid* lunch break got injured while surfing. His claim was denied because his injury did not occur in the scope of his employment. A judge settled the claim petition with a Section 20 for \$3,500 with claimant being responsible for his own medical bills. She noted that this shows the importance of training and description of job duties. She urged the members to utilize the training provided by the JIF.

Annual Exposure Renewal Process – Mr. Forlenza noted an email will be sent shortly from Ms. Palmeri to indicate when the process has begun. He informed the members that Exigis has moved the database to a new platform. Members will see little difference in how the system works.

Fireworks – MEL Bulletin – Mr. Forlenza reminded the members that they must secure coverage if they are planning fireworks at their event. He urged members to not wait until the last minute to get coverage and please follow the bulletin guidelines.

Mr. Hansen presented the Treasurer's Report for the period ending May 31, 2015. The report was made part of the agenda packet for members' review.

Investment Interest

Net interest received for the current month totaled \$618.82 and a coupon payment of \$15,000, accrued interest of \$25,291.67. After including a realized and an unrealized net loss of \$9,980 in the asset portfolio, the yield was adjusted to positive .40 % for this period. The total overview of the asset portfolio for the Fund shows an overall unrealized gain of \$56,020 as it relates to market value vs. the amount invested.

Our asset portfolio with TD Wealth Management has a current market value, at month end, of \$28,039,470 and consists of two (2) with maturity of less than one year; four (4) obligations with maturity of 1-2 years and three (3) obligations with maturities greater than two (2) years.
