



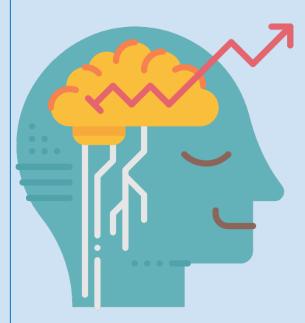




# **CHANGE YOUR MINDSET**
