RESOLUTION 2023 – 36

A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF JAMES GOOS TO THE ATLANTIC COUNTY MUNICIPAL JOINT INSURANCE FUND

WHEREAS, the Atlantic County Municipal Joint Insurance Fund (hereinafter “ACM JIF”) is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the ACM JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Atlantic County Municipal Joint Insurance Fund; and

WHEREAS, James Goos, the Fund Commissioner from the City of Ventnor, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the ACM JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, in recognition of his work and dedication to the core principles of the Fund, the members of the ACM JIF unanimously voted **James Goos** as an Alternate Member of the Executive Committee beginning in 2015 and as member of the Executive Committee beginning in 2017; and

WHEREAS, the ACM JIF wishes to recognize **James Goos**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund; and

WHEREAS, the Fund Commissioners of the ACM JIF wish to extend to Jim’s wife, the best of luck, the strength of tolerance, and ask that she have patience with Jim as he transitions to a life of leisure;

NOW, THEREFORE, BE IT PROCLAIMED, by the Commissioners of the Atlantic County Municipal Joint Insurance Fund assembled in a public session on June 21, 2023, that this body does hereby honor and congratulate **James Goos** for his many years of unselfish and dedicated service as a Fund Commissioner; and
